**BUSINESS MEETING MINUTES (Approved 7/20/15) Vote: 3 Yes, 0 No**

**Call Meeting to Order:** Meeting was called to order at 6:41 PM

**New Business:**

1. *Formal vote* to approve the application from Chris & Billy Anastasiadis to open a restaurant at 156 Maple Street. Sign Letter of Approval
  - a. *Motion to approve: Norm Harding, seconded by Ken Hall; Voted 5 Yes, 0 No. Approval letter signed.*
2. *Formal Hearing:* Frank Perry will submit a Site Plan Review on his property on High Road (Map R-02, Lot 004B) for residential land use in a resource protection area. Frank and Wes have prepared documents that may cover all the situations at hand.
  - a. After discussion and examining the Land Use District map and the Water Quality map, it was determined that no site plan review was necessary. Instead the Board will act as a consultant to the process, and the CEO, Wes Sunderland, will monitor the progress of the project. The Board urges the completion of the project well before the proposed time line of 2017.
