New Business:

1. Les MacMaster: MMOC
 - a. Updated progress to date;
 - b. Social clubs were discussed
 - i. Currently, there are no "clubs" in the Village Center or Historic District, so the Land Use Ordinance (LUO) can restrict them without stepping on toes. Les asked how do you want the committee to proceed?
 - ii. What constitutes a club? Perhaps the term needs to be defined.
 - iii. The draft will be scrutinized several times before it goes before the town for approval as an amendment to the LUO.
 - iv. John complimented Les for his leadership of the committee, and the progress made to date.
