

TOWN OF CORNISH
SELECTMEN BUSINESS MEETING
MAY 24, 2017

Selectmen Daniel Sherman and Mathieu Cama were present for the business meeting.

Steve Mellen of Mellen and Sons Disposal was present for the opening of the Trash Hauling Bid. Mr. Mellen submitted a three (3) year contract that includes the recycle hauling. Amounts of 1st year \$65,000, 2nd year \$70,000, and 3rd year \$75,000 with two (2) additional years at \$75,000. The selectmen decided to wait until the next business meeting so that Carlton could be present.

May 10, 2017 meeting minutes, Payroll and Accounts Payable Warrants were approved and signed.

The ARF (Action Request Form) from Kaye will be discussed at the next business meeting.

ARF from Margaret Aspinal, asking the Selectmen to appoint two members to the Sacopee Valley Rescue Board. Kaye will contact Ms. Aspinal about the wording for an advertisement.

ARF from Jay Traunig, Wes is looking into the matter.

Harvest Hill Animal Shelter will be sending out a revised contract in June.

W.L. Sturgeon submitted a contract to install a new water line for the sprinkler system; it will be placed on the next business meeting agenda.

The Tower Lease will be added to the next workshop for discussion.

Private Power Services submitted an estimate of \$750 to trim trees at Thompson Park and at the Fairgrounds. Motion made to accept Private Power Services proposal. All in favor.

Byron Harrington, Jessica Larson, Tiffany Parent, Steve Smith and Cliff Whitney volunteered to be on the Water Level Ordinance Committee. The Selectmen would like to meet with the committee on May 31 to discuss moving forward.

Mat is drafting a letter concerning the ARF from Aaron Parker.

Mat will work on moving the voting booths to the Fire Station for the June 13 Referendum and School vote.

Diann Perkins updated the Selectmen about the Eagle Mill Park Committee, Ken Hall was elected chairperson. Lorinda Connolly of Maine DOT (Department of Transportation) will be here tomorrow to deliver the Governors Deed. The Selectmen asked that the committee meet with them on June 21 to discuss what plans they have for the park.

SVHS (Sacopee Valley High School) Seniors will be here June 5-8 for community service. Dan will get the supplies for the town office and Diann will handle the supplies for the Fairgrounds.

Town Building Use Request was received from Scott and Mary Pingree to use the Fire Station on June 23. Motion to approve the request, all in favor.

Personal Property 2nd notices were sent out yesterday.

The bell at Thompson Park will remain pending business.

Memorial Day, Dan will line up the parade; Linc Carr will ride in Carlton's car. Mat will ask Major Bennett if he will lead the parade. Diann and Desirae will have the program complete tomorrow.

Email correspondence was received from Les MacMaster concerning the Recreational Marijuana Moratorium. Jessica Larson, Chair of the Planning Board, is on the agenda next week to speak to the Selectmen.

The Selectmen asked Kaye to compare Clark Insurance's policy for changes from last year to this year.

Diann stated that Jason and Andrea Roberts will be starting their farmers market June 3 and have another couple that would also like to join them.

Office update Kaye will call Mellen and Sons and ask about the cost of a dumpster. Desirae has more filing cabinets on the way. Kaye has called Sam Gilpatrick about getting rid of the metal.
