New Business:

- 1. Carr Site walk and application.
 - a. Discussion:
 - i. The site walk was well attended and revealed a small, neat operation.
 - ii. The overall discussion was positive.
 - iii. More work needs to be done at the next workshop meeting relative to setting parameters for the operation.
 - iv. There is ample room for parking.
 - v. J. Larson: It appears that all state criteria have been met.
 - vi. J. Morrissey: A buffer zone is not applicable in this case.
 - vii. K. Hall: Applicants must work with the CEO for any significant change going forward.
 - viii. E. Bergstrom: Consider putting a hand rail on the steps.
 - ix. N. Harding: Questioned the parking and noise from increased traffic. J. Carr: The trees will shield a lot.
 - x. D. Perkins: How fast will the trees grow to maturity? J. Carr: It depends on the type, but generally 5-10 years. Pomace will be distributed to local farms.

- 2. Formal Hearing: Shelby and Corey Oates, renters at 100 Maple Street, have an application for a conditional use permit to open a business to be known as *Sowing Oates, Inc. (Tattoo & Art Studio)* at (Map U-02//089). This lot is in a commercial district (CD). Abutters (31) have been notified and invited to attend.
 - a. Shelby and Corey Oates have presented the Board with an elaborate business plan. One abutter spoke in favor of the application. There were no further comments from the Board.
 - b. Norman Harding: Motion to approve the application; Ken Hall: Seconded. Vote: 5 Yeas, 0 Nays. Bill will prepare the letter of approval for signing.
- 3. Adult Marijuana Moratorium word changes?
 - a. The planning board suggests that the following passage be adopted into the proposed Cornish Adult Use (Recreational) Marijuana Moratorium as Paragraph 4, page 1: "WHEREAS, the proposed Act will not limit the privileges or rights afforded by the Maine Medical Use of Marijuana Act (22 M.R.S.A. §§ 2421 2430-B) to qualifying patients, primary caregivers, or registered dispensaries, including cultivation facilities associated with any of those classifications; and"
- 4. Other: Cliff Whitney requested to speak on the Mill Pond issue. Since it is not officially a planning board issue, notes were not taken.
