Call Meeting to Order: Meeting was called to order at 6:30 PM

#### **Unfinished Business:**

- Tom Magno gave an update on the Indecency Ordinance, reporting that he had turned the
  document over to the BOS for review by MMA attorneys. Selectperson Nancy Perkins reported
  that the only suggestion from MMA was that a sequence of steps to be followed should be
