**New Business:**

- Approve January 17, 2011 Workshop Meeting Minutes

**Unfinished Business:**

- Update on Public Indecency Ordinance - Mr. Magno
  1. See P.I. Ordinance Draft: The Committee made one correction on Pg. 2 and will be ready to take steps toward Town approval. The Planning Board discussed the procedure and responsibilities. Outcome: Selectmen asked for ordinance; the committee did exactly what was asked of them; Planning Board has seen Draft of P.I. Ordinance; Committee should hand off to Selectmen; Selectmen will hold Public Hearing.
  2. Guest: County Sheriff Maurice Ouellette: To explain cost for enforcement  
Sherriff Ouellette outlined the process the Town would have to go through in order to have law enforcement with regard to enforcing Town ordinances. There is a program to "Contract" with the Sheriff Department; a grant that paid the first 3 years by the Federal Gov't, the 4<sup>th</sup> year would be approx. \$18,000 (Salary & Benefits) paid by the Town. Consensus of PB members: A brief letter to BOS asking them to consider "Contract" Cop.

- **Planning Board Budget – Discussion regarding Presentation for Town Meeting**  
The PB reviewed a “hand out” prepared by Harding to be distributed to voters of the Town during Annual Town Meeting. Chair Sherman questioned the “comparison” chart, after discussion the membership agreed to remove.

**Public Comment:** Diann Perkins mentioned the P.I. Ordinance Committee is on the BOS agenda for their next meeting.
