 - a. Mr. Benggio has moved here from South Carolina and has purchased the property at 3 Old School Street with the intent of opening a bed and breakfast. Renovations have started and three rooms will be completed in August. Mat Cama pointed out that the Land Use Ordinance (page 96) defines a Bed and Breakfast as "Any dwelling with no more than three (3) individual guest rooms, in which transient lodging or boarding and lodging are provided and offered to the public for compensation for less than one week. This dwelling shall also be the full-time, permanent residence of its owner. There shall be no provisions for cooking in any individual guest room." Mr. Benggio inquired about the possibility of increasing the number of rooms in the future. That would be done either through the Appeals Board (See Land Use Ordinance, Article V, Appeals (pp. 92-94)) or by amending the Land Use Ordinance at a Town Meeting. Mr. Benggio looks forward to moving his family to Cornish.
