**WORKSHOP MEETING MINUTES (Approved 8/3/15) Vote: 3 Yes, 1 Abstain, 0 No**

**In Attendance:** Ken Hall, Bill Hoxie, Norm Harding

**Call Meeting to Order:** 6:30 PM by Norm Harding

**New Business:**

1. Mike Jordan, map R-1, lot #25-C, on Clark Road, wants to construct a horse barn. It has just recently been ruled by the SRCC that the barn location is not in the 500' buffer zone along the Ossipee River. [The Cornish map reflects a larger resource area (not the 500' as with SRCC ).]
  - a. Mike Jordan inquired whether or not he needed a site plan review to build a barn to house two horses on his property. Wes Sunderland stated that he had visited the site several times, and had paced off the distance from the Ossipee River and found it to be in excess of 500 feet. When questioned about the nature of the soil and elevation of the site, Mike Jordan replied that the subsoil was sand/gravel and the site was at least 12 feet above the river. He also said that the river had never flooded that high. Bill suggested that since the SRCC had no issue with the site, and their guidelines were stricter than the Planning Board's we should follow suit and not require a site plan review. Norm Harding stated that a formal vote could not take place at a workshop meeting, but the members present agreed in principle not to require a site plan review. Mike asked if he should be present at the August 3<sup>rd</sup> business meeting. Norm Harding stated Mike should attend in case there are further questions. Bill will put him first on the agenda, August 3<sup>rd</sup>.
