He filled out the form he was given and had it back by April 1, 1992. The State came out with a new form which he recieved in September of 92, he was also supposed to have a Forest Ranger walk the property and fill out part of the form, Willard states that he didn't know about the Forester needing to walk the property Willard also states that he didn't know that if he had the correct form filled out and the ranger walk his property he could have been able to have his taxes abated. Vinal remembers telling Willard about the Forester. The Selectmen will discuss this matter at the end of the meeting. no promises on what they can do.
