10. DENISON R1, LOT 60 WANTS TO KNOW IF IT IS LEGAL FOR MR. HALE TO RESTRICT THE USE OF A ROAD. MOTION MADE THAT HE SHOULD CONTACT THE C.O.D.E. TO FIND OUT LEGALITIES.
