Town of Cornish Selectmen's Meeting October 2, 2013

Vinal Pendexter, Nancy Perkins, and Dan Sherman were present for the meeting.

Selectmen Meeting minutes from September 18th, Accounts Payable and Payroll Warrants reviewed, discussed and signed.

Two requests to use the fire station presented.

- Matt Bennett, Cub Scout Den Leader and 6-7 Bear Scouts to meet October 8 & 15, November 5 & 12 from 5-6:30 PM. Approved to use small conference room and must clean up afterwards.
- Cierra and Cheyenne Calnan want to host a chili and chowder cook-off on October 27th from 4-6:00 PM. Also considering pasta dinner on November 3rd from 5-7:00 PM. Selectmen have reservations and need more information on the proposed cook off. Nancy will get Scott Pingree's thoughts on a chili & chowder cook off being held at the fire station.

Responsibility for cleaning the fire station continues to be an issue. Nancy proposed junior and senior football players clean the fire station for credit towards their Community Service requirement as the Football Boosters meet there each week during the season. The selectmen support the concept. Nancy will call Nate Carpenter to get the particulars of the Community Service Program and if he supports her idea, she plans to talk with the Football Boosters on Tuesday, October 08, 2013.

Discussion held on limiting who may request York County EMA assistance. It was agreed to add "Cornish Selectmen must authorize any request for York County EMA for any incident" to the Memorandum Of Understanding. Motion made to sign the Memorandum of Understanding for York County EMA after adding the Addendum. Seconded and approved.

Insurance coverage for the proposed fundraisers by the Fairgrounds Advisory Committee was revisited. Selectmen's concerns; where will the funds come from should an event require supplemental insurance coverage? Who will monitor the event to make sure there's no activity occurring that may put the town at risk.

A time will be set up for Andrea Todd, Clark Insurance, Diann Perkins and Selectmen are available to meet to discuss insurance coverage.

Bob Sturgeon reviewed and returned the most recent water mitigation drawings, Pete Simard's questions and observations from his review of the drawings, along with his own list of questions and comments for ATTAR Engineering, Inc's response. Dan offered to relay questions to Ken Wood.

Representatives from Senator Susan Collins office scheduled Tuesday, October 22 from 10 to 11am to meet with the public at Pike Memorial Hall.

Motion made to sign the document presented by Dennis Mowry and also that we set a date for Dennis Mowry to come and review the audit with us. Seconded and approved.

A workshop meeting planned for Wednesday, October 09, 2013 at 6:30 pm.

Several complaints received about questionable debris unloaded from trailers onto the ground at Robert Harrisburg's property. Code Enforcement, Water District, and Selectmen investigated the site and contracted DEP and Rural Water with their concerns of contamination as the property is located in the aguifer protection area. The debris from the trailers has been picked up off the ground and they are still working there.

The banking in back of Pike Hall shows signs of continued erosion toward the hot top and may require additional crushed stone to stabilize it through the winter. Will have Bob Sturgeon take a look at the area.

Painter found additional clapboards in need of replacement since Scott Franz did the initial repair work. Dan called Scott Franz met with him to point out the clapboards and Scott was able to replace them the following day.

Status of the Parking Ordinance; Ordinance reviewed at Planning Board Workshop, Matt Cama has had email correspondence with Derek Olson, DOT. Derek has sent the document to DOT legal dept to answer Matt's questions.

Vinal asked if there would be a Fall round of Grants through Time Warner Cable. Pat Junkins has had conversations with the representative of Time Warner. Time Warner requires the town have a substantial role in that obligation and Pat was going to make sure the deadline didn't pass. Dan will touch base with Pat.
