SELECTMENS MEETING  
OCTOBER 24, 1988

WARRANT FOR GENERAL ELECTION SIGNED BY THE SELECTMEN.  
MEETING CALLED TO ORDER AT 8:05P.M.

Sacopee Health Center has invited the selectmen to attend open house. Tom Carper will try to go to represent Cornish.

Historical documents- Mrs Ellis has documents that Martha Nee will try to get from the heirs. Selectmen feel if they are donated to the town, they should be stored at the Library if possible due to the dampness and cold in the basement of the town hall. Warren will check with the Library.

Firemens hall - Voted to open bids & then go into executive session to discuss the bids. Return to regular meeting and make decision to accept or reject any or all bids. Decided not to place a figure.

Saco River Corridor Comm. - APPOINTED as regular member , Donald Jack, Alternate member- Mary Taylor.

Questions raised after Planning Board meeting about the Comprehensive Plan. Tom will represent the Steering Comm. Tom thoughts are to try to help them this way and if not successful it will be necessary to hire someone. Marilyn McCulloch will find out about financial help if this becomes necessary.

Carroll Harding attended to discuss his 1988 tax bill. Ending valuation figure on buildings \$ 37,015.

Robert Barr- Personal 1988 tax questioned. The tax is against the furnishings and washer and dryer (s).

Establish values for revaluation- land values etc. Tom suggested checking with the town of Limington as well as surrounding towns. All agreed. Warren will handle .

SIDEWALKS- Ronnie & Tom have checked the sidewalks. Bob STUPELIS will do 300 feet and can start after halloween. Tom has talked to Bob Sturgeon about cutting so Basil Day can dig. Bob Sturgeon will charge \$2.00 a foot. Starting at Rt 25 on High St up to the large tree by the Gilmore'S property. Estimated cost per Tom. 5' sidewalk- Basil DAY \$500.00, Cutting \$80.00, 5' sidewalk at 4.50 - 3,075.00. Total \$ 3,655.00. Excavating and gravel included in Basil's estimate. Lapak at Cornish Inn agrees paving will stay.

with trucks parking in front of her house and sometimes blocking her driveway.  
He wrote a letter to the Dept of Transportation. They are willing to put up  
No Parking signs but feel the town should create an ordinance establishing  
No Parking from Rte 5 to Tel pole # 527. A fee of \$ 10.00 be charged for  
any person illegally parking there. He would be willing to find out how to  
establish such an ordinance. Question, who would enforce such a ordinance.  
Warren objects. No means of enforcing and has several complaints on  
various sites. Feels signs would be all over the town.  
Vinal Pendexter has stated , they will post on sign at W.B. Tripp store-  
Park on this side but has not done so. Police have tried also. Tom will  
do more research and report at the next meeting.

Ronnie- Cable is down at the old town dump. He will fix.
