

MINUTES OF SELECTMEN'S MEETING - October 8, 1990

Present: Warren Neal; Thomas Carper; Vinal Pendexter.

- 1) Carleton Candage of Steve's Heating Oil feels we need to have two oil tanks. MOTION MADE AND SECONDED THAT WE DO NOT PURCHASE THE 2nd OIL TANK. VOTE 3-0.
- 2) Front Doors: Northeast doors will get a price to Vinal. Gene Tewksbury also. Needs a heavy door. Vinal to also check with John Brower.
- 3) 5 tax abatements signed.
- 4) Two letters from Stephen DiBiaso. MOTION TO WRITE STEPHEN DIBIASO AND TELL HIM TO GO AHEAD WITH THE PLOWING. VOTE 3-0. Other letter just informational and is in file, regarding the on-going parking problem on Main Street.
- 5) Mike Rogers from the Bureau of Taxation here going over Tree Growth etc. Report due November 1, to be signed 10/11/90. Tree Growth is 440 acres short. Mike needs number of permits issued. Urban building values are low according to him. State ratio done, there was not enough property shold in 1989 to get a true ratio. CMP has been taxes two or three times. Warren would like to see each tax card color coded.
- 6) Tree Limbs: Stetsers and Fitts. There is a problem with having to remove wires, or unhook them. CMP might do this if there electric wires were involved. Talk with Francis Day??
- 7) Tax Discount: 3% if paid by 10/17. Tom suggests notifying all out-of-town tax payers and advise them of the discount and extend payment to 11/17/90. MOTION MADE AND SECONDED THAT THE PERIOD FOR A DISCOUNT ON 1990 TAXES BE EXTENDED FROM 10/17 to 11/17. VOTE 3-0.
- 8) Ben Viola: Not been contacee. Warren will catch him before next meeting.
- 9) Safety Committee: Diane Parkinson, John Pease, Woody Hartford. Tom to contact Donna Day, Mickey Pingree and Norman Scott. Ernest Rose isn't really interested and Cathy Carr will help.
- 10) Parking Lot next to Odd Fellows Hall: The church group has ear marked the money to repair chimney. Maybe next years funds will be available.
- 11) Raymond Benson's Bill: Two huge holes in sidewalk, he repaired them then notified the town would like Town to pay for the work. Pay out of Sidewalk account.
- 12) O. B. Denison. Would like abatement on prior years error. MOTION MADE AND SECONDED TO ADVISE O. B. THAT WERE A TRUE AND PERFECT STATEMENT WAS NOT FILED AND THERE IS NOTHING SELECTMEN CAN DO. VOTE 3-0.
- 13) Elizabeth Morris: Taxes and Bob Sturgeon's crew damaged her property stone wall, etc. Selectmen to view, Wed. 6 p.m. at Vinal's.
- 14) Tax complaints must be taken care of Wed. at 7:30 p.m.

- 15) MERC: Geneva asked if the Town was considering going to Portland. \$1. more per ton. And suggested that we get at it right away
- a. Notify MERC
 - b. Town has to vote to get out of MERC

- 16) SAD #55: Board of Trustees meeting to explain State School Funding. Selectmen to atten.


