MOTION MADE AND SECONDED TO ASK DON JACK TO SUBMIT AN ARTICLE FOR TOWN MEETING. VOTE. Town would like a written proposal. Tom feels the small flags are more appropriate than a large flag. Ronnie feels we should have a note to the town. Letter to go to Don Jack.
4. Perla & Phil Anderson re sewage going into Little River. Dian Perkins states the above.
5. David Jordan here in regard to house to house pickup of Solid Waste. 540 buildings assessed in Town - projected 55 more house lots. Contracted 360 tons per year at Merc. Need place to put old wood and large furniture, white goods David can store. Limerick pays \$52,000 per year. Wants stipulation in Contract with the Commercial/Business people that no other carrier be allowed. Tom asked for copy of Limerick contract.

13. Letter received by Selectmen from Dr. Brown about Tomb Hill. Warren wrote to F. Sanborn and Dr. Brown, copies of letter in file. Ronnie suggests we contract Tomb Hill to Elwyn Day. Warren asks if this would be a breach of contract with Franklin.
14. Bob Sawyer: called re Noah's Rand Road, W. Pease, Wilfert complained people were down the road building fires. put gate across. Bob Sawyer is concerned the road is closed and there was no vote of the town. Me. Municipal states closed road, Town votes and it reverts to owners. Abandoned road, 20 years, and then it reverts. Peach and Wilfert state it is going to be closed. Bob Sawyer said he will open the road and go down and hunt and fish. Road has been abandoned more than 20 years and it has reverted back to landowners.
