

MINUTES OF SELECTMEN'S MEETING - December 16, 1991

1. Warrants signed.
2. Salt and Sand Agreement: Between Town of Cornish and Philip T. Day, Jr. MOTION MADE AND SECONDED TO SIGN A NEW CONTRACT WITH PHILIP T. DAY AT THE PRICE OF \$1,000.00. VOTE 3-0.
2. OLD LIMINGTON ROAD SIGNS DOWN: Ask Mickey to take care of these signs.
3. SIGNS ON WATERFRONT & CIRCLE DRIVE: Bent and twisted. Carlton to check this out on Tuesday.
4. PAUL HOWE: Was bill sent?? Work not done, so it wasn't. Work to be completed this evening.
5. Bob Scott: Tree Growth form not found.
6. CHASALCO: Received two tax bills. Will check into this this evening along with Clifford Strump and Paul Howe.
7. Sign and date concealed weapons letter. MOTION MADE AND SECONDED TO SIGN AGREEMENT WITH THE CHIEF OF STATE POLICE TO AUTHORIZE THEM TO ISSUE CONCEALED WEAPONS PERMITS FOR THE TOWN OF CORNISH. VOTE 3-0. Letter to be posted for public.
8. Ben Viola called re small community grants. There are no funds available, possible FmHA money available. Federal Grants provide 55% of the cost - 45% would come from the State as user fees. Town must hire Engineer - if work is not proper, Town must pay for Engineer. No Federal or State Funds are available. Federal Funds can be used to purchase land, but not State funds. MOTION MADE AND SECONDED THAT THE NOTES BE INCORPORATED INTO THE MINUTES. VOTE 3-0.
9. APPEALS BOARD: Those interested - Danny Day & James Burton MOTION MADE AND SECONDED THAT DANNY DAY BE APPOINTED TO SERVE ON THE APPEALS BOARD FOR A THREE YEAR TERM. VOTE 3-0.
10. JEFF CARPENTER'S BUILDING: Bruce to go ahead but wants the support of the Selectmen. (to condemn building) Selectmen always support Bruce in what he undertakes. Carleton will go in the house when they inspect it, also Mickey and possibly the Fire Marshall.
11. Gen Tewksbury: F. Sanborn was not plowing to J. Benson's house. Charlene called Franklin to take care of it.
