MINUTES SELECTMEN'S MEETING - February 23, 1987

Present: John Seelye, Bonnie Ouellette, Warren Neal, James Smith.

Items discussed:

1) Jim Smith here about Electrical Inspector position. This would keep people from putting in electricity on their own, as CMP would install only on his say so.. He is CODE inforcement officer for Scarborough and Parsonsfield. He would like to do Building, Plumbing and Electrical Inspectors, not CODE Enforcement Officer.

2) Planning Board: Stephen DiBiasco, Wilfred Taylor and Vinal Pendexter's terms run out May 7th. Original Ordinance cannot be found as to whether 5 or 3 years. Maine Municipal feels we probably were established when a 5 year term appointment was the rule. Re: Election of Planning Board; can not legally be in Town Report, must be posted 60 days, so an article cannot be done this year. Jim would like to post it now and have a Town Meeting in May. It was decided to appoint now for 3 years and them have a Town Meeting and have them elected. Marilyn McCullough; Mary Picchi; Jack Kelley; Tom Hosmer; Steve DiBiasco; Jim Bowen have all expressed an interested in serving on the Planning Board.

MOTION: That we appoint the three members to the Board for Three Years. Seconded. Warren, Bonnie for - Jim against.

3) Dump: \$8,000 was taken care of by special Town Meeting. Stephen has deed showing less acreage then Tax Map. SRCC will be the only problem. Must be 300' from river according from DEP. 100' from road for screen.

4) Town Report. Distribute the chapest way possible. If hand delivered, three Selectmen should do it. Cost of \$150 to mail

7) Memorial Day: Bonnie has ordered flags. Don will put the flags on the cemeteries.

8) Gordon needs a dry mop - will get it himself.

10) Gary Holstein would like the Selectmen to get together and have a growth Plan (5 yr. - 10 yr.) Meeting Sunday at 2 P.M. at Cornish Inn. Also wants sewerage problem resolved. Warren feels this all should be under Planning Board business.

11) Freddie Hayes, Gun Permit, duplicate. Warren does not want to sign this. State Police were concerned that he was shooting across the road. He say he was shooting his own rabbits. No connection with his job as Dog Officer. Warren to get an opinion on this.

12) Code Enforcement Officer: Craig Kingsley retires March 1st. Appointed James Smith, II as of March 1, 1987. Jim to contact him to see if he will take on Code Officer.
