MINUTES OF SELECTMEN'S MEETING - FEB. 5, 1990

PRESENT: WARREN NEAL; R. OTHUSE; THOMAS CARPER

1. LIQUOR HEARING FOR ENTERPRISE REST. RICHARD AND SANDY PINKOS HERE TO REPRESENT ENTERPRISE. INASMUCH AS NO ONE CAME TO THE MEETING TO OBJECT, IT WAS VOTED 3-0 TO GRANT THE LICENSE.

2. HEARING GENERAL ASSISTANCE ORDINANCE:
MOTION MADE AND SECONDED TO ACCEPT THE G. A. ORDINANCE AS PROVIDED BY MAINE MUNICIPAL ASSOC. WITHOUT CHANGE. VOTE 3-0. (ADDITIONAL COPIES OF THE ORDINANCE NEEDED, MAINE MUNICIPAL WILL PROVIDE.)

3. ANDREW CLEAR HAS ASKED IF THE TROPHY CASE IN BASEMENT IS FOR SALE.
MOTION MADE AND SECONDED TO TABLE HIS REQUEST PENDING INVESTIGATION. VOTE 3-0.

4. LISA PYBURN RE DOG AT RICHARD SARGENTS. LISA IS UNCOMFORTABLE GOING TO THE HOUSE.
MOTION MADE THAT THE SHERIFF'S DEPT. BE CONTACTED, THEN STATE POLICE. VOTE 3-0

5. SCOT BLANCHET WOULD LIKE THE TOWN TO BUY A NEW SHOVEL.
MOTION MADE AND SECONDED THAT THE TOWN PURCHASE A NEW SHOVEL FOR SCOTT. VOTE 3-0. CALL GORDON TO PURCHASE A GOOD ONE.

6. DANCE HERE ON FRIDAY NIGHT. DANCE WENT WELL. CLEANED UP GOOD.. THERE ARE 5 NO SMOKING SIGNS MISSING PLUS THE COVER TO THE THERMOSTAT. MOTION MADE AND SECONDED THAT \$25. BE WITHHELD FROM SECURITY DEPOSIT VOTE 3-0.

7. LETTER FROM DENNIS MOWRY, CPA. PROPOSAL TO DO TOWN AUDIT FOR 1989 FOR \$3,000.

8. PAT SCULLY RE WISEHART MATTER - PURSUE IN COURT AND DO WHAT IS NECESSARY. RE VIDEO VENTURES - THEY HAVE HIRED KENNETH CLEGG TO REPRESENT THEM. NOT CLEAR AS TO WHAT THE PROBLEM IS. A. SIGN. B. PARKING. MR. SCULLY WANT TO KNOW WHAT PROBLEM TO GO AFTER.. REFERRED TO BRUCE SMITH AND HE STATES THAT PARKING IS THE BIGGEST PROBLEM.

9. REG. PLAN - SO. ME PLANNING COMM. RE POLICE PROTECTION. BUY JOINING TOGETHER WITH OTHER TOWNS IT WOULD BE COST EFFICIENT. THIS IS A RECOMMENDATION IN REGARD TO COMPREHENSIVE PLAN.
