- Art. 25. \$2,000.00 to be taken from <u>Surplus</u> if necessary, <u>plus</u> \$1,000.00 to be raised in taxes for resurfacing and repairs of sidewalks.

- Art. 36. it was voted to charge 12% interest per annum on tax liens.
- Art. 37. it was voted to discount real estate and personal property taxes paid within 30 days from the date of committment at the fixed rate of $1\frac{1}{2}\%$.
- Art. 38. it was voted to charge 2/3 of of 1% per month (8% per annum) on unpaid taxes after January 31st.
- Art. 39. it was voted to pay the Treasurer 2% on tax lien collections.
- Art. 40. it was voted to authorize the Selectmen to appoint all necessary town officers (other than elective officers) for the ensuing year.

Art. 43. \$5,000.00 to be raised in taxes to establish a fund for the future solid waste disposal in conjunction with the other 4 towns.

Art. 44. this art concerning the Solid Waste Interlocal Agreement was passed as stated in the annual report with the following ammendment: "with changes made by the attorney General".

Art. 46. This art. concerning the proposed elderly housing was passed as stated in the annual town report.

Art. 47. it was voted to change the date of the annual town meeting to the third Monday in March.

Art. 47B. it was passed to change the zoning in/front/of of the Donald Letart property from Agricultural to All-purpose.

Art. 48. \$2,500.00 appropriated from Fed. Rev. Shar. Funds for operating expenses of the Sacopee Rescue Unit.

Art. 49. \$5,760.00 appropriated from Fed. Rev. Shar. Funds for waste disposal in conjunction with the other 4 towns.
