MEETING CALLED TO ORDER BY CHAIRMAN NEAL.

1. M. MCCULLOCH HERE REGARDING PLANNING BOARD APPOINTMENTS. SHE STATES THAT MAINE MUNICIPAL SAYS THERE IS AN ORDINANCE THAT ESTABLISHES THE TERMS OF OFFICE FOR PLANNING BOARD MEMBERS. WARREN WAS ADVISED BY MAINE MUNICIPAL NOT TO RESCIND THE VOTE TAKEN AT THE LAST SELECTMEN'S MEETING AS IT WOULD LEAVE THE TOWN WITHOUT A PLANNING BOARD. THE STATE USED TO GOVERN PLANNING BOARDS, THIS WAS APPEALED, NOW THEY ARE GOVERNED LOCALLY.

MARILYN ASKED IF THE SELECTMEN WERE GOING TO IGNORE THE ORIGINAL BY-LAWS OF THE PLANNING BOARD. MADGE BAKER TOLD HER THAT THE BY-LAWS ARE BACKED UP BY STATE STATUE.

TRADITIONALLY ALL PLANNING BOARD MEMBERS HAVE BEEN APPOINTED FOR 3-YEAR TERMS. TOM STATED THAT THE SELECTMEN DID DISCUSS 3 YR. VS. 5 YR. TERMS. IN THE PAST 3 YEAR TERMS WERE ORDINARY, AND THEY DID NOT FORESEE AN OUTCRY BY APPOINTING A 3, 4 % 5 YEAR TERM. THIS IS SENSIBLE AS NOT A RGE GROUP WOULD BE GOING OFF THE BOARD. THE 3, 4, & 5 YR. VOTE 3-0. AT WHICH POINT MARILYN MCCULLOCH RESIGNED FROM PLANNING BOARD AND AS CHAIRMAN OF THE COMPREHENSIVE PLANNING BOARD.
