

**Town of Cornish
Selectmen's Meeting
April 30, 2014**

Nancy Perkins, Dan Sherman and Emily Ward were present for the meeting.

Mathieu Cama presented website developed to date. Discussion of costs, domain name, navigation bar, document security and email policy. Matt will maintain site at no cost to the town. Matt and Emily will collaborate on design aspects.

Robert Sturgeon estimates an hour and a half and \$150 to do HHE200 test pits. Dan will schedule the HHE200 test with Robert Sturgeon and Ken Wood.

Motion made to have WL Sturgeon place a rock barrier at the streamside lot per the \$500.00 estimate he provided. Seconded and approved.

A DOT representative to view damaged fence at Route 25 and Cumberland Street and sidewalk sections that have dropped 3" on both sides of bridge. Nancy will arrange meeting.

The Sidewalk Account balance will determine the scope of repair work to be done on High Road sidewalks. High Road drainage cannot be resolved until major project is funded. The road is higher than sidewalks directing water runoff towards properties. Discussed temporary solutions.

Two dead trees need to come down. Dan will investigate CMP's responsibility to remove the Rock Maple tree leaning into CMP wires on Roland Day Road. The second is a huge 100' Pine tree in back of Cornish Elementary currently fenced off to protect children. Brush and tree trimming to be addressed on Bracket Road during scheduled roadwork.

Robert Millard, Code Enforcement Officer discussed his resignation effective June 1, 2014. Letter acknowledging CEO years of service will be prepared by Nancy on Friday. An ad for CEO vacancy to be placed in Shopping Guide.

Warrants and Minutes reviewed and discussed. Motion made to accept the Warrants and Minutes. Seconded and approved.

Painting of crosswalks is scheduled for 6-6:30 am on May 25th with a rain date of June 8th.

Selectmen agreed Emily contact HARRIS Computer Solutions to investigate Appraisal Software and Bangor Savings Bank representative to investigate Town use of credit cards.

Cornish Historical Society approved for use of lower level of Pike Memorial Hall on June 19th. Noted CHS items stored upstairs and at the old fire station that need to be removed.

Sacopee Valley House of Pizza Liquor License Application reviewed and signed.

Contact information added to Pre Application Letter and sent on to Connect ME by Dan Sherman.



Nancy June 19 - 22.


Motion made to adjourn meeting.
