- Jon Pease came in would like to know the status of his road? It is the same as it was at Town Meeting. The road was presumed abandoned do to the lack of maintenance. Can't find any maintenance records for the Marryfield Rd. Jon says it is a County road, Carlton can't find anything in the County records. Jon says that the Selectmen of Cornish and Limington got together and bought the road in 1883, there is a question as to what road was bought. The State Statute on abandoned roads was read out loud, Chapter 3 page 11. It is Carlton's opinion by reading this that the road is abandoned and it is up to the land owner to prove differently, based on the fact that there is no evidence of municipal moneys being spent on the Marrifield Road. Jon wrote a six page letter and would like a response to it. He would also like the Town to find out where the Town lines are. Vinal suggests that we talk to a surveyor to find out. Motion to allow Vinal to get intouch with a surveyor to find out where the Town lines are on the Marrifield Road and to respond to Jon with a letter and try to get it done within a two week period.
