## MINUTES OF SELECTMEN'S MEETING MAY 16, 1994

Present: Carlton Candage, Vinal Pendexter, and Derrall Watson.

- 1. Meeting called to order at 7:00 PM
- 2. Teddy Day, Phillip T. Day II, Lori; Phil's wife, and sister Melonie Smith are present to discuss the salt and sand storage contract. Melonie intend to open on advise of Martha Weeks-Trail this meeting is to be taped. The Town and the Day's taped the discussion. In November the Town received a letter of request for an increase of \$1000.00 for the storage of Salt and Sand. There is a question as to increasing in mid year, the Town only voted to appropriate \$1000. for that tax year. There has been nine contract years beginning in 1984, the 84-85 year being the first. Melonie has the deposit slip and letter from Marsha Weeks dated March of 85 for the 84-85 year.

What are the Day's intentions? Payment for the 1993-94 year and if we wish to continue they need to go with the new contract. It's 100% increase were did they come up with this increase? The taxes have increased more than 100%. There is no contract for the 1993-94 season.

- 13. Planning Board vacancies Lillian Bell expired in March 94 and Rickeresigned
