- 2. FRANK PERRY HERE REQUESTING PERMIT TO DUMP AT MERC. MUST PROVIDE MERC WITH NAME, MAKE AND LICENSE NUMBER OF ANY TRUCK GOING TO BIDDEFORD. MOTION MADE AND SECONDED TO PROVIDE FRANK PERRY WITH PERMIT TO DELIVER SOLID WASTE TO MERC. HE WILL PROVIDE SLIP FROM TIPPING TO TOWN. VOTE 3-0.

- 9. KILLDEER ACRES: LETTER RE ESCROW ACCOUNT FOR ROADS FROM MADGE BAKER. ANY IMPROVEMENTS SHOULD BE DONE THROUGH PLANNING BOARD. BARBARA CONOVER HERE IN THIS REGARD, FEELS "NO BUILDING PERMIT TO BE ISSUED" IS NOT SUFFICIENT HOLD—BACK. SHE SUGGESTED LOTS 2—8 CAN ONLY BE SOLD IN THEIR ENTIRETY, NO INDIVIDUAL LOT CAN BE SOLD UNTIL ROAD IS BUILT OR CONTRACTORS MAKEL NEW LETTER OF CREDIT. PLANNING BOARD MUST APPROVE THIS.
