

MINUTES OF SELECTMEN'S MEETING - May 9, 1988

1) Parade: all o.k.

2) Stacy Development: 2 lots that are partially in Cornish and Limington. In 1975, more or less, an agreement was made between the Selectmen of the two towns that one lot would be taxed Limington and the other by Cornish. A lien was placed on Dionne's property by Cornish. Both towns are taxing this lot. Letter was read by the Selectmen of Limington. Lot R2 - 46 Dianne, is listed as lot 25 of the Stacy Subdivision. Letter to Limington Selectmen.

3) Salt and Sand Agreement between Gloria Day and Town. MOTION MADE AND SECONDED THAT THE AGREEMENT BETWEEN THE TOWN OF CORNISH AND GLORIA DAY FOR THE USE OF LAND FOR STORAGE OF SALT AND SAND BE SIGNED AND THAT SHE BE NOTIFIED BEFORE JULY OF THE TOWN'S INTENT TO LEASE IT FOR THE 1988-1989 SEASON. VOTE. 3-0.

4) York County Civil Serv. regarding Hazardous Waste Plan. Tom Hosmer is interested in this. Industries that have hazardous waste list to be sent to York County Civil Emergency Preparedness. Warren to call.

5) June 20, 1988 M.E.R.C. is to be 25% greater for Tipping Fee.

6) David Birchfield has requested a raise. 3/4 of building permit fee instead of 1/2. 3/4 of plumbing permit fee. Ronnie feels he is not spending enough time on the job. Warren made MOTION TO TABLE IT UNTIL HE REQUESTS IT AGAIN SECONDED. VOTE 3-0

7) Clean-Up Day: Sat 9.a. May 14. Gordon will truck away debris. Who is going to pay him.

8) Two requests from Circle Drive, Mr. Robbins and Burt Henry on Speeding. Motion to show them the signs and if they wish to purchase one that is fine. SECONDED VOTE 3-0. Tom or Warren to see Mr. R.

9) Warren has seen about having the lawns mowed in the past. He will do it again this year.

10) Youth program: Mowing, raking, painting etc. Warren has agreed to Supervise them.

11) Town Road across from Dall's Diner. Can it be used for an in/out road shows on tax maps, so Selectmen do not believe it is a town road.

12) Ray Estabrook, his road is a old County Road or a R.O.W.

13) Tom an Warren to go out assessing on Wed and Thursday of this week. Do transfer Wed. evening.

14) Richard Taylor: Tom has read through the deeds.
