- 1. Meeting called to order at 7:05 pm.
- 2. Jeff Carpenter present to discuss his building, he would like to take it down, but doesn't have the money to do so. Estimated cost of \$2,500. to take it down, plus it would need to be filled in. Jeff is willing to work with the Town Jeff doesn't have any suggestions on what to do with the building that are pallitable to the Selectmen, the Town, or himself at this time. If the Town paid for the cost of taking it down would he be willing to turn over the deed to the Town? Bruce squelled things with her neiber Mrs. Dunn, she called Bruce to see and he told her to make provisions to have enough land so it doesn't interfer with her own property and so Mrs. Dunn wouldn't let her.

When Bruce wouldn't issue a permit for resident she asked if it was a studio for personal use he said yes and put that on the permit.
