- 2. MADGE BAKER HERE JUST TO MEET THE SELECTMEN. SPOKE OF POSSIBILITY OF A \$30.00 PER HOUR CHARGE IN ADDITION TO ANUAL DUES AT MMA. IN THE OFFERING, BUT HAS TO BE VOTED ON AT ANNUAL MEETING. PLANNING BOARD WILL HAVE TO CURTAIL CALLS.
- 3. COMPREHENSIVE PLANN COMING ALONG WELL.
- 4. WHEN ASKED ABOUT ABOUT WHITE GOODS ILLEGALLY DUMPED IN CORNISH, SHE REPLIED THAT THE C.O.D.E. OFFICER SHOULD CHECK INTO IT.
- 5. JIM LAPAK: HERE IN REGARDS TO HIS LIQUOR LICENSE. HE APPLIED A YEAR AGO, TOWN HAD HEARING AND SIGNED THE LICENSE, HE, HOWEVER, DID NOT RETURN IT TO THE LIQUOR COMMISSION AS THEY DECIDED AGAINST SERVING SUPPER AND ANY LIQUOR. NOW THEY ARE READY TO SERVE AGAIN LIQUOR COMMISSION SAID THE APPLICATION COULD BE RESIGNED AND DATED. HAVING ANOTHER HEARING WAS UP TO THE SELECTMEN. THIS WAS WAIVED AND MR. LAPAK HAS HIS APPLICATION. HE ALSO INVITED THE SELECTMEN TO A CORNISH BUSINESSMEN MEETING ON JUNE 20TH AT 7 P.M. AT STONE RIDGE. THERE MAY BE A CONFLICT WITH A MEETING SCHEDULED WITH THE COUNTY COMMISSIONERS. WILL CHECK IN A.M. AND LET MR. LAPAK KNOW.
- A. DAVID JORDAN: VERY IRATE BECAUSE F. PERRY WAS DUMPING AT M.E.R.C. AYS THE TOWN SHOULD NOT PAY THE PER TON CHARGE TO LET MR. PERRY DUMP. FEELS HE HAS THE CONTRACT FOR CORNISH. WARREN CHECKED WITH MMA AND THEY MOVISED HIM THAT THE TOWN SHOULD PAY FOR MR. PERRY. DAVID MAINTAINS WHEN HE PICKS UP IN TOWNS THAT HE DOES NOT HAVE THE CONTRACT, HE PAYS THE TIPPING FEE. VINAL FEELS THAT THE TOWN HAS AN OBLIGATION TO TAKE CARE OF COMMERCIAL WASTE IN CORNISH. THE SELECTMEN WILL CHECK AGAIN WITH ATTORNEY FOR LEGAL OPINION AND SUGGESTED DAVID JORDAN DO THE SAME.

BOTH TOM AND VINAL WOULD LIKE TO SPEAK WITH BRUCE BEFORE THEY SIGN AND ALSO HAVE WARREN LOOK AT IT.
