

## Selectmen's Meeting July 2, 2008

Vinal Pendexter and Nancy Perkins were present for the meeting.

Accounts payable and payroll warrants along with minutes from the June 18<sup>th</sup> meeting were reviewed and signed.

MSAD#55 2008-09 stipend amount for Cornish is reduced by \$1,000 a month.

Diane and Nancy met with representative of Bangor Savings on Friday, June 20<sup>th</sup>. Several accounts show incorrect signature authorizations. Lucy will review at Bangor Savings' main office and report findings back to Diane. Selectmen made decisions on the signature authorizations for the accounts. Nancy stressed the importance of following through with the changes.

Quit Claim Deeds signed for Richard Aaron properties. All property taxes are now current.

 Peggi made the repair to the men's toilet.

No response to our appeal for a handyman. John Brower will be contacted to see if he'd be interested.

Nancy proposed the surrounding towns' selectmen and sheriff's for the respective county meet to discuss "potential issues" of the Up North Festival being held at the Ossipee Fairgrounds in August.

A suggestion to relocate the recycling containers to the Town's property being used by Freddie Hayes was discussed. To help the rotation of an empty container on site it was suggested we purchase an additional container. Diane will investigate cost of a new container. Vinal asked if a definitive answer from Herrick's on the probability of the old fire station as the site has been made. Diane has called Herrick several times but has not gotten an answer. Nancy offered to speak with Herrick's to set up a site visit.

Attorneys Steeves and Graff sent a letter indicating the price breakdown of expenses for the purchase of the Riverside Cemetery property. Selectmen determined the Town's expenses to be \$1,300+ and the seller's expense to be \$540 plus the cost of the survey.

Nancy presented the background work she has done in an effort to set an assessment amount for the bulk fuel facility on Mason's property. Vinal suggested that Nancy contact David Sawyer who assesses for Gorham and Windham.


Bernstein, Shur, Sawyer, and Nelson sent a solicitation letter and CD of their services relative to Internal Revenue Service law.
