Accounts Payable and Payroll Warrants and Business Meeting Minutes reviewed and approved.

RHR Audit all issues were addressed and finalized. Dan moved to accept the draft as the final report, Mat seconded, all in favor. The report was signed by the Selectmen.

Snow Plow Contract. Three years without a bond just the roads and add a physical disability clause. Dan motioned, Mat seconded, all in favor.

Update on Old High Road. New law in effect on July 29, 2016, discontinuing a road form completed. Need a letter from Bob Sturgeon confirming that the road is abandoned, and send a response letter. Mat motioned to consider Old High Road below the private road Anderson Drive abandoned by history and state statute at .1 miles taken by the Road Commissioner. Dan seconded, all in favor.

DOT cut more trees by Little River Bridge.


Spare Key for the Town Office. Pick up the day needed with 24 hours to return it, with a log sheet.

Meeting Adjourned 7:20 PM




