MINUTES OF SELECTMEN'S MEETING - July 28, 1986

Present: Warren Neal; Dr. DiBiasco; John Seelye

Matters discussed:

1) Freddie Hayes wages - Dr. pointed out that Freddie does use his own equipment and have Joyce help him. Jim made Motion that we pay Freddie \$6. in the future. Warren was against it; he feels that people on town assistance should do it for nothing.

Motion made: That Jim Seelye purchase a mower between \$150 and \$200. and use Town Assistance people to mow. Seconded VOTE.

Warren will read guidelines, to be sure we are in line.

Freddie turned in bill for \$6. per hour and he regularly was paid \$5.00. Dr. would like to get the difference for him. It was voted to pay him the difference of \$15.00.

2) Joan's salary: \$4.50

6) Taxes: Complete. Some assessments are done and will be finished up on Thursday. Ratio still o.k.

7) Computers: No programs for a town our size. Cost of programs quite high, \$2,500 - \$3,000.

8) Beverly & Ezmund Day: Next step is to get an attorney to write to them. Warren to contact Bob Batchelder.

9) Dog Complaint: Harmon's at Gladys Hawley's, big black dog, barked all night. Dog is chained.

10) Luidas Normantas: Pay new amount or old amount? Parsonsfield paid old amount. Hiram to pay old amount. Hold off as long as we can. Warren will call the other towns to see what they are going to do.

11) Eva Lord's property: "Hell of a mess". Bill Taylor is to contact the Cemetery Assoc. and is waiting to hear from them in
