MINUTES OF SELECTMEN'S MEETING - August 12, 1991

Present: Warren Neal; Vinal Pendexter; Carleton Candage

- 1) Stan Thompson here regarding resurfacing the parking lot adjacent to Town Hall. It is owned by him, used by Accessories Unlimited. The Town Road goes around its perimeter. Mr. Thompson said that there was a verbal agreement about 25 years ago in regards to the maintenance of the parking lot. There is nothing written in regard to this. Mr. Thompson to get estimates on doing the Parking Lot and Bob Sturgeon is to get estimates on doing the Town Road. The Selectmen agree that there should be a written agreement made. A meeting is planned to bring in all estimates and an amount determined to be appropriated at Town Meeting. Work estimated to be done in the summer of '92.
- 2) Ronald & Judith Leonhartt here in regard to the increase in 1991 taxes. Warren explained the increase and will go over their bills upon receipt of deeds, etc.
- 3) Nancy Rogers here regarding her taxes. Vinal explained the increase. She stated her ~~land~~<sup>lot</sup> was more wasteland than brush, the Selectmen will go over her land and make the necessary adjustments.
- 4) Quit-Claim Deed: David and Jane Warren signed.
- 5) Michael Welsh: Warren wrote him explaining why he cannot have a rebate. R8 Lot 3.
- 6) Mary York: Would like to have a Benefit Dance in Russell Moody's name for a Scholarship in his name. MOTION MADE AND SECONDED TO ALLOW THIS DANCE AND CHARGE A FEE OF \$50.00. Vote 3-0.
- 7) Town Hall Rentals: Increase in fees to be discussed at next meeting.
- 8) Richard Sargent: He is legally blind, State stated that if he could prove he does have interest in the property, he could have the \$5,000 exemption for being blind. MOTION MADE AND SECONDED TO GRANT RICHARD SARGENT A \$5000.00 EXEMPTION FOR BLINDNESS. VOTE 3-0.
- 9) Copies of increase sent to Irwin Sawyer, Donald Stone and Bonnie Titcomb.
- 10) Planning Board ad in Shopping Guide.
- 11) Robin & Jonathon Thorne: going through Bankruptcy Chapter 7 rather than 11. A lien cannot be placed on the property without permission of the Court. Town should have to hire an Attorney at the rate of \$500. to collect \$418 in taxes. MOTION MADE AND SECONDED TO WRITE THE COURT OBJECTING TO THE DISALLOWANCE OF THE CLAIM ON PROPERTY. VOTE 3-0.

12) Wisehart: Pat Scully states Disclosure next. Does the Town want to pursue this,. MOTION MADE AND SECONDED THAT THE TOWN REQUEST PAT SCULLY NOT TO GO THROUGH WITH THE DISCLOSURE HEARING, RATHER, LET THE MATTER DIE A NATURAL DEATH. VOTE 3-0.

13) Concealled Weapons Permit: Towns can have State Police issue the permits. Town will have a list of permits issued. Warren to call Maine Municipal. ~~MOTION MADE AND SECONDED TO~~ MOTION MADE AND SECONDED TO LET THE STATE POLICE ISSUE PERMITS. VOTE 3-0.

14) Work Session for Selectmen Wed & Thurs.

15) Vinal: Fees collected for issuing licences. MOTION MADE AND SECONDED TO INCREASE THE \$1.00 fee to \$2.00 and the \$2.00 to \$3.00. Vote 3-0.

16) MARK MAYHEW: Would like to do a Parade around the Holidays. There are no funds available for this,. MOTION MADE AND SECONDED TO TELL MR. MAYHEW THERE IS NO PROBLEM HAVING THIS PARADE, THERE ARE NO FUNDS TO HELP. THERE IS A \$50.00 FEE FOR A NON-PROFIT ORGANIZATION TO USE THE HALL. VOTE 3-0.

MOTION MADE AND SECONDED TO ADJOUR THE MEETING VOTE 3-0.
