Executive Session 1 M.R.S.A. § 405(6) (F)

Property Use Policy was discussed and the following guidelines were amended. A refundable deposit of \$100.00 will be required for the use of Town Property in Group A and B. This will be returned to the payee once the property has been inspected and deemed to be clean and free of damage. ***A monetary donation will be accepted.***

The requester is responsible for the cleanliness and security for the area of the property being used. This includes hallways and restrooms in buildings. ***Use of the Fire Barn excludes entry to the offices, dispatch room, or bay areas.***

No tape, pushpins, staples, or attachment devices which could cause damage will be used for affixing things to surfaces, ***including the ceiling.***

Dan motioned to accept the amended guidelines. Mat seconded. All in favor. Once edited the guidelines will be added to the website.

Byron Harrington requested to be on the Parks and Recreational Council. Dan motioned to appoint him as an active member of the Rec Council. Mat seconded. All in favor. Emily will email Tom Pingree about the out of town volunteer.
