MINUTES OF SELECTMEN'S MEETING - August 7, 1989

Present: W. Neal; R. Othuse.

1) Snowplowing Contract - a. Limerick Steeplejacks, with Surety program. Bondable for 30% of contract. Bid was \$53,000 (Plowing 34,000, sanding 19,000) b. Bid included no evidence of bond - Winn of Newfield. for \$48,000.

MOTION MADE AND SECONDED TO AWARD SNOWPLOWING AND SANDING CONTRACT TO LIMERICK STEEPLEJACKS. VOTE 2-0.

2) Salt Shed: Dwight Mills to build Salt Shed for Parsonsfield, Porter and Cornish.

3) Town will take care of stockpiling sand.

4) Park: No parking 10-5. Selectmen can issue No Parking Band, but a Curfew requires and Ordinance passed at a Town Meeting. State Police advise that if the Park was closed it would provide them something to go on. Table until group from Park arrive.

5) Mr. Markell Video Ventures: Did not appear at meeting. Warren called Madge Baker, So. Me., regarding the home business. She is to return the call on the 8th. No action until we hear from Madge Baker.

6) Bill Johnson would like to rent Fire Hall for 7-8 Jamacians. The water has been turned off. Electric meter must be moved per CMP.

MOTION MADE AND SECONDED THAT WE RENT THE FIRE HALL IF MR. JOHNSON WILL PAY ALL THE EXPENSES. VOTE 2-0.

7) Bruce Smith would like to take a course at SMVTI. Cost \$100. This would apply to his certification.

MOTION MADE AND SECONDED THAT BRUCE SMITH TAKE THIS COURSE. TOWN WILL PAY THE FEE OF \$100. VOTE 2-0.

MOTION MADE AND SECONDED TO GO INTO EXECUTIVE SESSION.

MOTION MADE TO GO OUT OF EXECUTIVE SESSION.

4) Park: Group here included R. Parker, J. Lapak, S. Coolidge, and R. Aaron. R. Parker - in favor of closing the park. Group has been calling Sheriff's Dept. and State Police Screeching of tires and noise big complaint. Lapak: Parking ban should coincide with curfew.

MOTION MADE AND SCONDED THAT SIGNS BE ERECTED AROUND THOMPSON PARK "NO PARKING BETWEEN 10 P.M. and 5 A.M. vote 2-0

Discussion: Number of signs. Where posted. Will get legal opinion as to how many signs to be posted. If you go to Court they must be clearly marked. (1 between Carr's and park 2 on High Road and 2 on Route 25)

Closing Park between 10 P.M. and 5 A.M. will require  
a vote of the town. Special Town Meeting - August 23rd  
at 7:30 p.m.

MOTION MADE AND SECONDED THAT WE WORK TO ADOPT AN ORDINANCE CLOSING  
THE PARK FROM 10 P.M. to 5 A.M.. VOTE 2-0.

The group discussed calling the York County Commissioners and  
requesting an additional Sheriff be hired for this area.

MOTION MADE AND SCONDED TO ADJOURN THE MEETING.
