

Town of Cornish Selectmen's Business Meeting September 14, 2016

Emily Ward, Daniel Sherman, and Mathieu Cama were present for the Business Meeting.

Accounts Payable, Payroll Warrant and August 31 Meeting Minutes were approved and signed.

The Selectmen meet with Peggi Aspinal of the Sacopee Rescue Board, to discuss adding new board members. Peggi will communicate with Kaye on the wordage of an Ad for the Shopping Guide.

A four Town meeting; a contract for the four towns; lack of a paramedic on all calls; breakdown rate of units; criteria for filing a grievance with the Rescue Board, and the delivery date of the new Rescue Unit were discussed. The Selectmen will follow up with Peggi on Oct 5 or Oct 12 at 5PM.

The Selectmen meet with Sandy Howe, Calista Cross, and Diann Perkins from the Historical Society to discuss the Boston Post Cane. They presented the Selectmen with a new list and a notebook with documentation of what they have found so far.

Dan asked that Desirae check to make sure that the Amerigas rate is \$1.39 as was written in the contract.

Tree Growth letters were signed and are ready to be sent.

Insulation from Peter Fleweling was received. Peter is contacting an Arundel Contractor about the labor for the Fire Barn.


4 and 5 Town Meetings. No word from Rob Heard.
