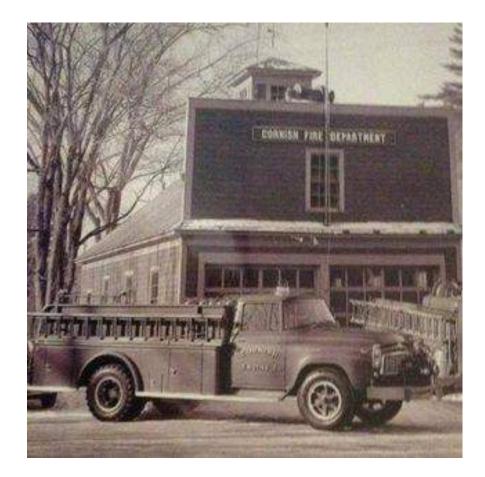


DEDICATION

The Spirit of America Award was established to recognize volunteerism and the Cornish Board of Selectmen selected Diann W. Perkins as the 2021 Spirit of America recipient for her tireless dedication to many hours of committee work.

Diann Watson Perkins was born in Cornish, Maine in April of 1937. She graduated from Cornish High School and the University of Maine in Orono. Her teaching career started in 1959 at Brewer Junior High and continued at Old Town High School, Bangor High School, University of Maine Orono, Gorham State College. Diann continued her career as a teacher in 1967 at Sacopee Valley Junior Senior High School until 1992.

Diann married Linwood Glen Perkins in 1958 and they raised two boys, Jay Farley and Perry Hugh. The family returned to Cornish in 1965.

Her love for the Town of Cornish and her sense for civic responsibility were inherited from her parents. Growing up she saw their volunteer work during World War II, the 1947 fire and many other town committees.

- If you wish to speak, wait until the Moderator has opened the floor to public comments. When the Moderator has recognized you, you will stand; state your name for the record, the agenda item and nature of your business.
- > Please refrain from discussion on the article if you have a conflict of interest in any article.
- > The Moderator will not entertain public comment about specific individuals.
- The Moderator has the right to set a time limit for comments. Be prepared to state your business in a brief and concise manner.
- > During a Public Meeting, only the subject matter can be discussed.
- Comments should always be courteous. Personal and accusatory comments are out of order. Profanity, disorderly language, or gestures at meetings are prohibited.
- At no time will the public be allowed to argue, debate, or introduce a topic that is not on the agenda.
- During discussion, the audience shall not disturb the proceedings by whispering, talking or other distractions

Friday, March 18th, 2022 2:00PM - 8:00PM Opening of Polls and Election of Town Officials

Monday, March 21st, 2022 7:00 PM-Adjournment Town Meeting voting on Articles in Warrant

The secret ballot laws provide that all officers are to be elected by a plurality vote. In other words, if there should be three or more candidates for any one office, the one receiving the greatest number of votes, not necessarily a majority, is declared the winner.

On the heels of 2020's challenges, 2021 brought us both amazing progress and frustrating setbacks. The incredible rollout of several effective, FDA approved COVID-19 vaccines helped reduce the risks of this deadly pandemic – but vaccine hesitancy, combined with the dangers of new variants, have prolonged this crisis and created new risks for Maine people. The challenges raised tension levels to boiling points during the fallout of the 2020 presidential election and the January 6th Capitol attack. But despite that, Congress was able to deliver for a nation gripped by an unprecedented pandemic. As we reflect back on the year, we see the important action that will make a difference for Maine people – as well as work still unfinished.

As COVID-19 continued to impact communities across our state and the country, Congress's first priority this year was to confront the pandemic's health threats and economic toll. We immediately got to work on the *American Rescue Plan*, crafting an emergency bill to meet the moment and get our nation back on stable footing. The legislation delivered essential support to businesses facing crises, households in need, and the medical professionals on the front lines of this fight. The funds helped get vaccine shots in arms, while also confronting the damage done to our economy. All told, the *American Rescue Plan* is bringing billions of dollars to Maine, helping the state continue to push through this crisis and bounce back stronger than ever.

After passing the *American Rescue Plan*, Congress turned its attention to a longstanding but unfulfilled priority: infrastructure. Through hard work and compromise, both parties came together to pass a bipartisan bill that finally addresses key infrastructure needs. For Maine people, the bill means an estimated \$1.5 billion to repair crumbling roads and out-of-date bridges, \$390 million to improve access to clean drinking water, and more. I am most excited about the significant funding for broadband – because, as we have seen during the pandemic, broadband is a necessity to succeed in the 21st century economy. The historic investments in the bipartisan infrastructure bill, combined with additional funding I pushed for in *the American Rescue Plan*, will bring an estimated \$400 million for broadband home to Maine. These funds will be nothing short of transformational, creating new opportunities across our state.

These two bills have made and will continue to make a real difference for Maine people, helping to both address the challenges of COVID-19 and lay a foundation for long-term success. I am proud of what we've accomplished this year – but I know there is still a lot of work to do and that the road ahead is challenging. Even still, I am filled with optimism because I know the true nature of our citizens, though challenged, has not changed. Despite every hardship, people in towns and communities have stepped up with strong local leadership, a willingness to help, and a Maine 'neighborhood' spirit. It is why I truly believe we can and will get through anything together. Mary and I wish you a happy, healthy, and safe 2022.

Dear Friends:

I am deeply honored to serve the people of Maine in the U.S. Senate, and I welcome this opportunity to share some of the areas I have been working on over the past year.

The ongoing COVID-19 pandemic continues to pose enormous challenges for our state and our country. When the pandemic began, I co-authored the Paycheck Protection Program that helped small businesses remain afloat and keep their employees paid. In Maine, our small businesses received more than 47,000 forgivable loans totaling \$3.2 billion. I also led efforts to provide relief for loggers, lobstermen, and bus companies.

In addition, I helped secure \$700 million to assist Maine's overwhelmed hospitals and nursing homes, and a new law I led prevented Medicare payment cuts to help further ease the financial strain on our hospitals. I also urged the CDC to update its recommendations so that our students and teachers could safely return to their classrooms, and I pressed the Administration to end the closure of the U.S.-Canada border.

While addressing the pandemic has been a major focus, I've also worked hard to ensure Maine's other needs are met. A group of 10 Senators, of which I was a part, negotiated the landmark bipartisan infrastructure bill that was signed into law in November. I co-authored the section of the bill that will provide Maine with as much as \$300 million to expand high-speed internet in rural and underserved areas.

Soaring inflation is another crisis, particularly when it comes to the cost of heating oil. I have strongly supported federal programs that help Maine families stay warm. In November, Maine was awarded \$35 million to help low-income Mainers pay their energy bills. And the bipartisan infrastructure bill included \$3.5 billion to help families make energy efficiency improvements that would permanently lower their heating costs.

As a senior member of the Appropriations Committee, I have supported investments in Maine's communities. This year's funding bills include \$265 million I championed for 106 projects across Maine. These projects would help create jobs, improve workforce training, address the opioid crisis, and increase access to childcare and health care services. In addition, I worked to reverse proposed cuts to our Navy in order to help protect America and keep the skilled workers at Bath Iron Works on the job. The bills also include \$475 million for the construction of a new dry dock at Maine's Portsmouth Naval Shipyard that will allow the Navy to continue to carry out its submarine missions. I will keep working to get these important bills enacted.

No one works harder than the people of Maine, and this year I honored that work ethic when I cast my 8,000th consecutive vote, becoming the only Senator in history to do so without ever having missed a roll call vote. The Lugar Center at Georgetown University once again ranked me as the most bipartisan Senator for the eighth year in a row.

In the New Year, I will keep working to solve problems and make life better for the people of Maine and America. May 2022 be a happy, healthy, and successful one for you, your family, and our state.

I hope this letter finds you well. It is an honor to represent you and your family during these challenging times, and I am thankful for the opportunity to update you on my work in Washington and Maine.

The COVID-19 pandemic continues to cause challenges for people in Maine and across the country. Please know that the health and safety of you and your loved ones, as well as the economic recovery of our communities, remains the driving force behind legislation I have pushed for in Congress.

In early 2021, Congress passed the American Rescue Plan, historic legislation that makes investments to crush the virus, create millions of jobs, provide direct relief to working families, and help schools remain safely open. Not only did this legislation give 90 percent of American households a stimulus check, but it also helped local and state governments better respond to the pandemic, put food on families' tables, got more vaccine shots into arms, cut child poverty in half through the expanded Child Tax Credit, and so much more. From funding to repair our aging roads, bridges, and ports to high-speed broadband expansion and legacy pollution clean-up, this law is a once-in-a-generation investment in our future.

In addition to working on COVID-19 relief legislation, my Congressional colleagues and I are also collaborating on legislation that addresses the climate crisis, supports voting rights, and—through my role on the House Appropriations Committee—supports programs important to Maine.

After seven years on the House Appropriations Committee, I took the gavel and lead the subcommittee that oversees discretionary spending for the Department of the Interior, the Environmental Protection Agency, US Forest Service, and several agencies related to the arts and humanities. In my new role as Chair, I have fought to secure significant funding for Maine's tribes, environmental preservation programs, our cultural economy, and our forests.

I will keep pushing legislation to support America's long-term care needs, lower prescription drug costs, expand Medicare benefits, cut taxes for working people, make our workforce competitive with the world, and fight climate change.

So, as we reflect on 2021, let us welcome 2022 with a renewed sense of optimism. There is a lot to fight for, and I assure you I will continue to fight for Maine in Congress. I want you to know that my staff and I are doing all we can to support Mainers through this public health crisis and all the challenges that come with it. SACO RIVER CORRIDOR COMMISSION

"Communities Working Together to Protect Our Rivers"

The Saco River Corridor Commission (SRCC) was created with one purpose in mind – to protect the rivers in the Saco Basin and all that these rivers represent to the people that live and work here. The legislature provided the performance standards to initiate the program, and the cleanliness of the river is a testament to that effort. The Commission's role is one of partnership. All twenty corridor towns can appoint two representatives to the board. The Town of Cornish is fortunate to have Laura Turner on the Commission. The Commission provides the Town of Cornish an opportunity to participate in the present and future development patterns throughout the entire corridor from Fryeburg to Saco. In this way, the Commission functions more like a local/regional group working to keep the water clean and preserve natural resources within the corridor to protect public health and quality of life in southern Maine. Clean water is Maine's greatest asset. It is hard to understate this important fact.

It is a fact that many people come to Maine from other places. Invariably, as areas are built up, inappropriate land-use planning can cause degradation to the shoreland area, along with water quality-based problems. The number of permits issued in the corridor has significantly increased since 2019, with 63 in 2019, 99 in 2020, and 115 so far this year, reflecting a 45 percent increase.

The SRCC has concluded the 20^{th} successful year of our Water Quality Monitoring Program. Currently, staff and volunteers monitor for dissolved oxygen, conductivity, pH, turbidity, temperature, total Kjeldahl nitrogen, orthophosphates, alkalinity, nitrogen (NH₄, NO₃ + NO₂), total phosphorous/phosphates, ammonium, and *Escherichia coli*. Our testing takes place bi-weekly along the Saco, Ossipee, and Little Ossipee Rivers at 37 different locations from May through September.

The SRCC is currently working with FB Environmental to produce a 10-year analysis of all data acquired by Commission staff and volunteers for water quality status and trends throughout the Saco Basin. This report will be provided to your town when it is complete. Thanks to another Maine Outdoor Heritage Fund grant, the Commission will purchase advanced bacteria monitoring equipment for the 2022 season. The equipment will enable the SRCC to analyze *Escherichia coli* (*E. coli*) more effectively and more frequently and will increase the timeliness of rapid response testing if high levels of *E. coli* occur. If the town has any recommendations of other recreational or public sites that you believe should be monitored, please let us know. We aspire to better serve our communities, and a large part of that is protecting public health.

The Commission has extensively updated our website to reflect these program changes, and all information related to the past twenty years of the SRCC's monitoring program is available. We hope that this information can serve as a useful resource for Planning Boards, Code Enforcement Officers, and developers in determining appropriate types of land uses close to the river.

The SRCC's mission is to work with the communities in the corridor to help keep the rivers clean and preserve the quality of life in southern Maine. Sacopee Valley Recreation Council

Sacopee Valley Recreation Council has provided a wide variety of programs for members of the communities in this area since 1989. SVRC is a registered non-profit



organization The council conducts business through a board of directors who are volunteers and two part time paid coordinators. Currently our paid coordinators are Kathy Hewey and Jocelyn Neilsen. Their coordination of duties, communication skills, and great work ethic certainly contribute to making this small program work in big ways.

Normally we plan and oversee engaging and diverse activities—including traditional sports programs for youth in grades K-6, imaginative summer camps and a low-cost learn to swim program, not to mention a number of free offerings such as open gym, cross country skiing and ice skating, women's volleyball, Friday night cribbage, and Easter egg hunts. In March 2020 everything changed due to COVID and many things still remain in limbo even now.

This past spring, we were able to have sign-ups for baseball and softball after not having a season in 2020. With COVID restrictions it was decided that players would need to have their own bats and helmets. Therefore, it was voted to waive the usual registration fee for everyone this year. The program went well. Karate continued as before.

Summer camps resumed in 2021, with great attendance and interest. We were still not allowed to use school indoor facilities, but we were able to use Ossipee Valley Fairgrounds for two camps, we had basketball camps outdoors on the tennis courts at the high school, and soccer camp was at the Cornish fields. The Field Hockey camp was at the elem. school fields and Pickleball was held at the tennis courts. By late fall we had worked with the school district to have pickleball lines painted on one tennis court and that came at a cost of \$800.

In the fall soccer and field hockey were both successful. We were still using Cornish fields which worked out wonderfully well. In November we were given permission to conduct a basketball program in the elementary and middle school gyms as long as we followed the current guidelines of masking and setting limits on spectators in the gyms. A record number of youth signed up and at present all games are scheduled to be played at Fryeburg Rec center. Rick Buzzell of Fryeburg is coordinating all game schedules, securing referees, and setting league rules. This makes it easy for us, but it comes with a cost.

We continue to have expenses such as advertising, insurance, and equipment as well as coordinators pay. We hope to be able to add more activities as time goes on if we can do them safely and have a place to do them. We have had no fundraising opportunities and we are doing what we can to keep the fees as low as possible. And lastly it is our mission to provide our programs to any and all children regardless of a family's ability to pay.

None of this would be possible without the help and support of the citizens of the five towns. We would like to thank everyone for this support, and we want everyone to know that we welcome more folks to join us in supporting recreation in the area. If you have a desire to help in any way, please let us know.

We are pleased to introduce to Cornish residents our new librarian, Trisha Banks! We hope everyone comes to the library to say hello! Please help us welcome Trisha to our wonderful community. She is looking forward to meeting all of you and building a lasting relationship.

In 2021 Bonney Memorial Library had 3318 patron visits, who borrowed 6,287 items such as books, musical instruments, games, etc. The library purchased 418 new books. While many programs were suspended, we look forward to our partnership with adult education and other community clubs and organizations in 2022.

We have noticed some interesting changes to the way people use the library during the pandemic. People are getting five and ten books rather than one. They are using curbside pick-up rather than browsing. They are making telephone calls rather than using face to face librarian assistance. Homeschool families are looking for whole collections of materials to study. The library operates 17 hours a week during a variety of times of day to accommodate busy schedules. The library continues to adapt to our patron's needs and our time.

Sacopee TV2 Annual Report 2021





As we do every year, we would first like to thank the towns for their continued support of Sacopee TV2. Without your ongoing support, this valuable program would not exist. Sacopee TV2 is a "win-win" because it provides an important service for the community by broadcasting both school and public events, while simultaneously providing our high school students with valuable skills in video production, post-production editing, video graphics, professional communications, and many others. Students actively engage in learning valuable real-life TV/video production experiences as they develop the skills necessary to manage the public access channel. Numerous Sacopee TV2 alumni have gone on to study broadcast communications in college and to pursue careers in multiple communications-related fields.

We continue to add updated programming for our viewers in the MSAD 55 community and around the globe through the use of streaming web media content. Thanks to the support we receive from the towns, we have been able to purchase Wirecast broadcast equipment which enables us to broadcast live from any location with WiFi. This capability has allowed us to significantly broaden both the number and the type of events that we can make available to our viewers. Wirecast has also enabled us to add more broadcast features, including a live running score for sports broadcasts and an information footer showing things like speakers' names at meetings. These features have given our broadcasts a much more professional look and have significantly improved the viewer experience.

Our YouTube channel allows viewers who do not have access to Sacopee TV2 via Spectrum Channel 2 to view the same content online. By simply going to our YouTube page, anyone can view our most recent programming. Any of the events on our YouTube channel can be watched at any time anywhere in the world where there is an internet connection. We have viewers from all parts of the United States and beyond and our list of subscribers continues to grow. This time last year, for example, we had 320 subscribers. Currently Sacopee TV2 has 495 subscribers, and that number continues to increase each week.

The COVID-19 pandemic, which struck shortly after the conclusion of the 2019-2020 winter sports season, has presented many challenges to Sacopee TV2 from 2020 to present. Many of our staple live broadcast events such as MSAD 55 School Board meetings moved to a virtual Zoom meeting format, and then of course the spring interscholastic sports season was cancelled for 2020. However, Sacopee TV2 was able to provide a platform for events to be held virtually which otherwise would have had to be cancelled. In 2020, we held the first annual Sacopee Scholars Telethon, which replaced the annual door-to-door fundraising drive to support senior scholarships, and the JROTC end-of-year awards ceremony. As we make progress in fighting the battle of the COVID-19 pandemic, many events have made their way from Zoom back to in-person. Sacopee TV2 continues to attend each event.

With the start of the 2021-2022 school year, Sacopee TV2 has provided an important service to parents, family, and community members by broadcasting live events that were largely closed to spectators because of the need to maintain social distancing and remain in compliance with state gathering restrictions. So far this year these events have included 32 home interscholastic athletic events (boys' soccer, girls' soccer, and field hockey), the annual Cornish Horse Races held 9/12/21, and the National Honor Society induction ceremony on 10/06/21, monthly school board meetings, the SVHS Winter Concert held 12/08/21. Last year, SacopeeTV2 was asked to create a short film representing the Hiram Historical Society to produce a tribute to the founding fathers of Hiram. SacopeeTV2 members worked diligently for several months on the project with Sally Williams. The video was almost an hour long and the end product was well received by many. In the springtime, we will be completing our annual 3–4-minute promotional videos for each of the towns that support Sacopee TV2.

In August of 2020 we sadly said goodbye to Heath Cormier, who resigned his position with MSAD 55 as well as the Sacopee TV2 coordinator position in order to take a position in another school district. Thankfully, we had Mr. JR Stevenson stepped up to take on his position. Despite it being his first year, he demonstrates great skill and passion for Sacopee TV2. We would like to thank him for stepping up and keeping the program alive. We are currently working with getting him up to speed as well as working to get Channel 2 updated. In addition to Mr.Stevenson, we would like to recognize and thank all of the Sacopee TV2 students, teacher, and principal for their help to keep this wonderful program alive. Mrs.Taylor and Mr.Wolfe have been there for many years and have always been willing to step up to take on roles not designated to them, especially in the absence of a coordinator in years past. The current students for Sacopee TV2 are: Hailey Capano '22 (station manager), Dylan Shields '22 (asst. station manager) ,Cassidy Shea '22, Sophie Shortsleeves '22, Tyler Muise '23, James Ritter '24, Dylan Capano '24, Elana Ford '24, and Elise Hermance '24.

We encourage towns as well as community groups and organizations to contact us about important announcements or events they would like listed on our community bulletin board or broadcast on Sacopee TV2. Please note that the Sacopee TV2 warrant article does not require the town to raise any revenue. The franchise fee is a fee paid by each Spectrum Cable subscriber which is returned to the towns.

Most municipalities dedicate these franchise fees to their local public access station, which in your case is Sacopee TV2. It is our goal for Sacopee TV2 to be self-sufficient, so that we will not require MSAD 55 funds or donations from area businesses in order to maintain operations. All Sacopee TV2 funds are managed by the MSAD 55 finance office and are audited annually with records kept for at least seven years. Once again we would like to thank the towns for their continued support of Sacopee TV2. ANNUAL REPORT FOR THE YEAR 2021

- The exhibit for Maine's Bicentennial, "Cornish in 1820", opened a year late due to Covid restrictions. This exhibit was open to the public for some Saturdays in July September with masks and other safety measures in place.
- Historical had to once again cancel the Duck Derby, a very popular community event in April. CAB's Apple Festival could not happen this year, but CHS did have an outdoor bake sale and open house with the Church and Library on that September Saturday, which was well attended and included a special exhibit memorializing Donald R. Sargent and the ill-fated Flying Tiger Flight 739 tragedy of 1962.
- Five members of CHS serve on the Pike Hall Committee and have attended monthly meetings. CHS has donated to the "Friends of Pike Hall" plaque.
- CHS has had regular monthly meetings, some being on zoom, and has sent out three newsletters this year to members, with more copies available at Pike Hall and the Library.
- Officers have participated in online programs with New England Archives, and Maine Archives and Museums. CHS has collaborated with nearby societies to investigate how to upgrade and increase our outreach to the public in the future. CHS worked with Hiram Historical Society to create a zoom program "Shared History of Hiram and Cornish" in May.
- At the request of the Selectmen, research was done on the history of the Pike Hall lot and the neighboring house.
- More outlying cemeteries have been cleaned and GPS coordinates documented. CHS hopes to continue this and write up a new index for the many old buying grounds to aid families with their genealogy searches.
- Genealogical queries have been answered from families as far away as Wisconsin, Oregon, and California. Names researched were: Trafton, Day, Eastman, Sargent, Wales, Pendexter, Dearborn and Chadbourn/Chadbourne. Also two old house history write ups were completed as requested.
- A bake sale and 2022 fundraising calendar sale was held during Voting Day, Nov.2.
- Members assisted with the promotional article about Cornish for the Spring issue of "West Coast Maine" magazine.
- A request from the Cornish Water District to learn about the early history of the Cornish Water Company was completed and presented Dec. 4, 2021.
- A free public educational program at Pike Hall auditorium for Native American Heritage Month in October was very well attended.
- Antique framed engravings of Hon. Nathan Clifford were donated to Janet Carper and Bonney Library.
- CHS is a non profit 501(c)(3) organization. Interested visitors and new members are welcome.

Cornish Historical Society is very grateful to Bonney Memorial Library for the use of their 40 Main Street building, and grateful to the Town of Cornish for its continued support.

CORNISH WATER DISTRICT 2021 TOWN REPORT

TO THE CITIZENS OF CORNISH:

The Cornish Water District is a quasi-municipal non-profit corporation managed by an elected board of five trustees. We supplied 18,810,500 gallons of water during 2021 from both of our pump stations (Northwood Drive and Pavilion Road). In 2021 we pumped, on average, 51,536 gallons of water per day. The annual comprehensive tests done by the State of Maine laboratory indicated excellent drinking water quality.

In 2021 the Water District worked on or completed the following:

- 1. CCR (Consumer Confidence Report) was completed, published & distributed to consumers in July. The MDWP mandates this be done each year.
- 2. Flushed & exercised all 48 hydrants & blow offs in April & October.
- 3. Exercised all system gate valves & boxes cleaned.
- 4. Repaired several gate valves.
- 5. Repaired and replaced several curbs stop valves and boxes.
- 6. Purchased new generator and fitted to truck.
- 7. Installed 2 new water mains, valves and curb stops in Saco Woods.
- 8. New service lines installed Saco Woods & South Hiram Road.
- 9. New chlorine feed pipe fitted to #1 pump at Pavilion Road.
- 10. Completed quarterly bacteria tests required by Maine State Drinking Water Program. (Zero contaminates were found).
- 11. Maintenance updates to Pavilion Road included: painting pump room pipe work, propane tank, garage ceiling sheet rocked/insulated, new work benches built.
- 12. New Rhombus Lift Station installed at Pavilion Road
- 13. New start contactor for #2 pumps at both Pavilion Road and Northwood Drive
- 14. Stripped and rebuilt 5 chemical injector pumps.
- 15. Repaired security fencing Northwood Drive.
- 16. Cleared 2 service line freeze ups.
- 17. Repaired 1 service line leak on High Road.
- 18. Installed new chlorine feed pump at Northwood Drive.
- 19. Service & painted road compressor.
- 20. All fire hydrants painted, and caps color coded per AWWA standards.
- 21. Extended bush hogging area at Northwood pump station.
- 22. Installed 15 new lead-free meters & touch pad readers replacing outdated meters.
- 23. Replaced 22 failed touch pads.
- 24. Both touch pad meter readers serviced and updated.
- 25. Fire Extinguishers inspected and replaced as required.
- 26. Installed 21 winter bleeder systems to prevent freeze ups.
- 27. Updated the vulnerability assessment and emergency response plan as required.
- 28. Wellhead protection updated.
- 29. Completed necessary training classes to keep our operator licenses up to date.
- 30. Continued enforcement of Cross Connection Control Program with annual inspections. Reporting 100% compliance & working backflows.
- 31. Updated the water main system map.

- 32. New safety equipment for staff.
- 33. All outdated spare stock material was replaced with new lead-free materials.
- 34. Updated all software for computers.
- 35. Held 5 trustee meetings.
- 36. Completed annual audit.
- 37. Year-end inventory completed and outdated material disposed of.

2021 Sacopee Rescue

The last 2 years have presented many trials for all of us, the Rescue included. We have all grown from our experiences and are a stronger, better community for it. We look towards 2022 with great expectations towards building a better service and expanding our capabilities. After 38 plus years Chief Edgerly has decided to retire. The position under Chief Edgerly paid a stipend of \$4,000 most years. Often Chief Edgerly took no pay for the work that she did, basically volunteering her time and efforts. As such in 2022 the Rescue will be looking to hire a full time chief. This expense is reflected in the 2022 budget and is line itemed out under Chief Expense. `Addit5ionally labor cost has increased significantly in 2021. As labor cost is the largest part of the budge it also has the largest impact on the budget.

As the community progressed through the COVID pandemic the area saw an increase in population. This population increase also increased the number of calls that the Rescue received in 2021. The totally number of calls that the rescue received in 2021 is 984. Of those Sacopee Rescue handled 845 calls, (141 calls were handled by our mutual aid partners. For comparison in 2020 Sacopee Rescue handled 637 calls in total. This is a 32.65% increase for Sacopee Rescue handled calls over the 2020 call numbers. This increase in calls demonstrated that in 2022 we will need to add a second crew to help ease the use of mutual aid to cover all the calls that we are receiving. This second crew will start on a partial basis providing coverage during the times that historically for 2021 were the busiest.

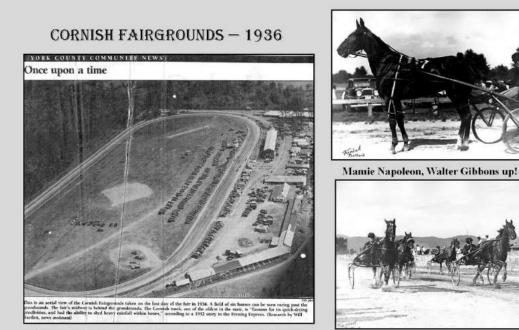
